## Call for Nominations

ACG Columbus 2025 Annual Networking and Awards Event will be held on Thursday, October 23, 2025, at Vitria on the Square. At this event, ACG Columbus will celebrate its 20th Anniversary while recognizing companies and service providers that have made significant contributions to the Central Ohio economy and community through innovation and excellence in mergers, acquisitions, and corporate finance transactions.

ACG honors and acknowledges the deals and deal makers as well as the accountants, bankers, lawyers, private equity firms, and other stakeholders who initiate, structure, and negotiate deals for growing organizations.

ACG Columbus is now seeking nominations for the following award categories:

### Deal of the Year Awards

These awards will recognize companies and service providers involved in transactions during 2024 and the first half of 2025 including mergers, acquisitions, significant capital restructurings, and ESOP formations. Primary considerations will include interesting or unique aspects of the transaction, the impact of the transaction on Ohio (including job growth and retention), and the impact of the transaction on the industry, and deals will also be evaluated on the complexity, challenges, and benefits of the transaction, as well as any unique attributes. Middle-market M&A transactions of all sizes will be considered.

### Innovation Award

This award recognizes innovation in the middle market by a company or service provider that has a new or expanded offering that represents a notable innovation within its industry or organization.

**How to Apply:** Organizations and individuals interested in applying should complete a nomination form in the relevant category.

### Who Should Apply/Nomination Criteria:

Organizations and individuals in middle-market business with \$10 million to \$1 billion of revenue and headquartered or doing business in Central Ohio. Investors, advisers, and other partners are encouraged to submit nominations, and self-nominations are encouraged. The strongest nominations are prepared collaboratively with key advisors and senior management working in concert to complete the nomination form with as much detail as possible as to what makes the particular transaction truly stand out. All details on the nomination form will be verified with the company before judging.
