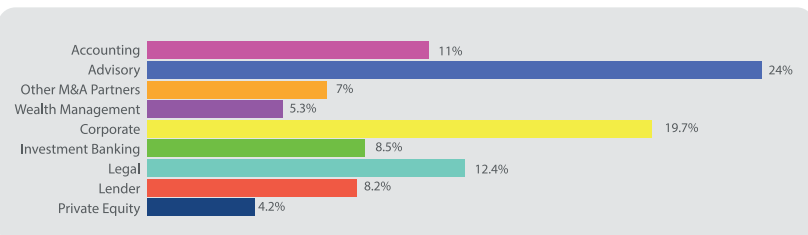

(Firms attended)

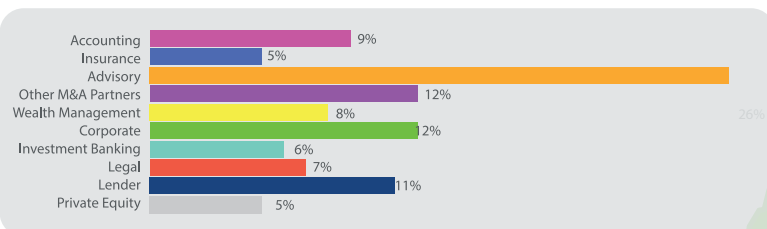
#### ► 50 Events\*

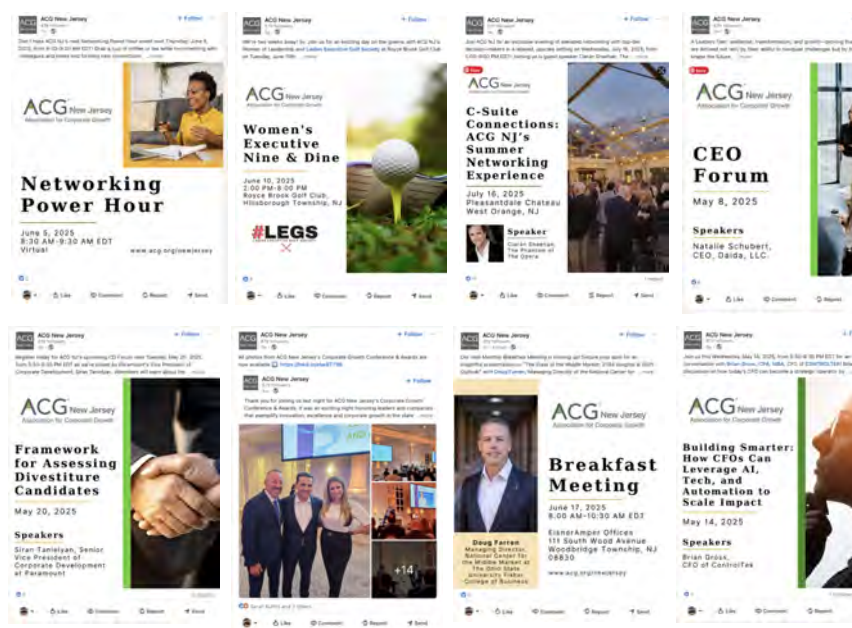

**ACG NJ CEO FORUMS**

"CEO Forum" is a discussion meeting over dinner for CEOs, business owners and other selected senior executives representing companies with annual revenues generally between \$25 million and \$1 billion+. A typical dinner discussion group has a CEO leading the discussion on an important topic of interest, with 25 to 30 CEOs attending. The event commences at 5:30pm with cocktails, passed hors d'oeuvres and networking, followed by a CEO led roundtable discussion concluding at 8:30pm.

**ACG NJ CFO FORUMS**

"CFO Forum" is a dinner meeting/ discussion forum for corporate and divisional Chief Financial Officers, Vice Presidents of Finance, Treasurers, Controllers and other senior financial executives from area companies generally with annual revenues between \$50 million and \$2 billion+. The group has been gathering for over 10 years and 250 CFOs having attended, with a growing group of "regulars." A typical dinner discussion group has a CFO leading the discussion on an important topic of interest, with approximately 20 to 30 CFOs attending. We also typically issue 1 CPE credits for each meeting. The event commences at 5:30pm with cocktails, passed hors d'oeuvres and networking, followed by a CFO led roundtable discussion concluding at 8:30pm.

**ACG NJ CORPORATE DEVELOPMENT (CD) FORUMS**

"CD Forum" is a dinner meeting/ discussion forum for Corporate Development Officers (CDOs) and other M&A, Transactional and

Strategy executives, generally from larger corporations. Over the 15 years of the Forum more than 200 CDO's have attended, with many current "regulars." A typical dinner discussion group has a CDO leading the discussion on an important topic of interest, with 15 to 25 CDOs attending.

**ACG NJ IN-HOUSE COUNSEL FORUMS**

"In-house Counsel Forum" is a dinner meeting/discussion forum for In-house attorneys of corporations, generally with annual revenues between \$100 million & \$5 billion+, including General Counsel, Chief Legal Officers and Deputy, Associate & Assistant General Counsel. Almost 200 senior In-house counsel have attended since our first meeting in 2008, with many joining us regularly. A typical dinner discussion group has a senior In-house attorney leading the discussion on an important topic of interest, with approximately 15 to 25 In-house Attorneys attending. We also typically issue 2 CLE credits for each meeting.

**ACG NJ ANGEL FORUMS**

"Angel Forum" is a breakfast meeting/ discussion forum for current angel investors and business owners andn senior executives wishing to learn about angel investing while getting connected with seasoned angels. The group has been gathering for twelve years and almost 150 angel investors, business owners and senior executives have attended, with many participating regularly. A typical breakfast group has an angel investor-leading the discussion on an important topic of interest, with approximately 20 to 25 angel investors and business owners/senior executives attending.
