The event presents the opportunity for intermediaries, corporate development officers, middle market executives, accountants, lawyers, senior lenders, other advisors and dealmakers to meet and greet with top private equity and mezzanine capital providers to fill their pipeline for the coming year.

  - o 161 Private Equity, Investment Bank, and Mezzanine Exhibitors
    - 105 firms were Capital Providers
    - 56 firms were Investment Bankers
  - 55 attendees were Corporate Executives
- 56% of attendees were from outside of Georgia
  - New York, Chicago, Florida, Texas, and the Carolinas were 31%
- 99% of survey responses rated this year's event as excellent or very good (1% increase from the prior year)

Each year, ACG Atlanta, the Atlanta Chapter of The Association for Corporate Growth® (ACG), a global professional organization focused on middle-market growth, mergers and acquisitions, and private investment honors the top 40 fastest-growing middle-market companies in Georgia.

#### The awards criteria are:

- Eligible companies must be for-profit and headquartered in the State of Georgia
- Most recent year-end revenues between \$15MM & \$1B
- Three years of verifiable revenue and employment counts.

- 321 attendees
  - 131 from the 40+ honoree companies
- 24 industries represented
- 55% of honorees have won this award before
  - 13 honorees this year have won more than 3 times
- 45% were honored for the first time this year
