

Call for Nominations – Rising Stars Category

The Dealmakers of the Year Awards is Vancouver's premier annual award recognizing successful transactions in the M&A middle market. We are pleased to present awards to individuals and firms who have demonstrated the entrepreneurial skills and the diligence necessary to build a company's value and complete a successful exit transaction. Dealmakers is the opportunity to celebrate the achievements of British Columbia's M&A professionals and acknowledge industry excellence.

Rising Stars Nomination and Selection Criteria

The Rising Stars Award focuses on recognizing the contributions of emerging leaders with less than seven years experience in the industry who have contributed to the prosperity of BC middle market companies through dealmaking.

Nomination Criteria

- Private company, middle market deal community participant resident in BC, having contributed
 as associate or advisor to the prosperity of BC middle market companies through M&A,
 divestitures, joint ventures, or strategic alliances.
- Focus will be on transaction activity over the last two to three years.
- Nominees are to be individuals.

Selection Criteria

- Demonstrated contribution to successful transaction activity.
- Demonstrated initiative or contribution to improving deal value or outcome, for example, through stakeholder management, risk-mitigation, client service, thought leadership, or contribution to structures / strategies / deal terms.
- Success relative to peers in prevailing market conditions.
- Known or growing presence in the BC M&A middle market community.
- Impact on BC's deal making community more broadly.
