**ACG ATLANTA ANNOUNCES 40 FASTEST-GROWING COMPANIES IN GEORGIA**  
*Honorees are recognized at the Celebration in June.*

May 5, 2026: ATLANTA - The Atlanta Chapter of the Association for Corporate Growth® (ACG), a global professional organization with the mission of Driving Middle Market Growth®, yesterday announced the 2026 Georgia Fast 40 honoree class, recognizing the top 40 fastest-growing middle market companies in Georgia.

“The companies being honored this year exemplify ACG’s focus on driving middle market growth and demonstrate the strength and significance of this sector in Georgia,” said Meg Williams, Executive Director of the Association for Corporate Growth’s Atlanta chapter.

Applicants were required to submit three years of verifiable revenue and employment growth records, which were validated by the national accounting firm and founding Diamond sponsor, Cherry Bekaert LLP. An ACG Committee evaluated each company and conducted interviews with all qualified applicants. All companies on the list are for-profit and headquartered in Georgia. These firms reported 2025 year-end revenues ranging from \$15 million up to \$1 billion.

“These 40+ companies have contributed over \$8.6 billion in revenue, and currently employ almost 16,000 employees throughout the state of Georgia. These companies have added over 8,100 jobs since 2023,” said Luis Reyes, Chair of the Georgia Fast 40 Awards and Partner at Cherry Bekaert, longtime Diamond sponsor of the event. “In speaking with many of the CEO’s, the supportive business environment and accessibility to capital are key contributors to this growth. We are proud to honor these companies and look forward to learning more insights online and at the celebration in June.”
