Welcome to the 2017-2018 ACG Dallas/Fort Worth season. We are excited that you will be a part of our continued growth and success in the coming year.

The Chair and Co-Chairs are integral parts to ACG DFW as we have 13 committees that participate in a wide range of activities. The leaders set the precedent by steering the committee and its goals from June 1, 2017-May 31, 2018.

Typically, the Chair is responsible for the following:

- Select a Co-Chair
- Establish committee members for the year
- Schedule quarterly meetings, two in person (minimum of 6 for programs and membership)
- Meeting agenda sent day prior to meeting
- Delegate events and duties
- Event budgets (coordinate with ED)
- Attend or dial in to Board of Director's Retreat in May

Typically the Co-Chair is responsible for the following:

- Email meeting notes and action to group
- Help drive committee goals and engagement
- Lead on one event
- Fill in for Chair as needed
- Facilitate committee member engagement

Typically the Committee Members are responsible for the following:

- Help drive committee goals year round
- Actively participate in planning and execution of events and programs
- Market events through professional networks
- Attend events

Succession Plan within ACG:

A minimum of two to three years of ACG service is required before you are considered for a seat of the Board. There are several other factors considered such as length of membership, level of engagement within ACG, primary function, etc...

Committee Chair recommendations are made and reviewed by the ACG DFW Board of Directors.

ACG Dallas/Fort Worth Board of Directors meets monthly on the third Thursday of every month after our breakfast or lunch meeting, with the exception of December, June, July and August.
