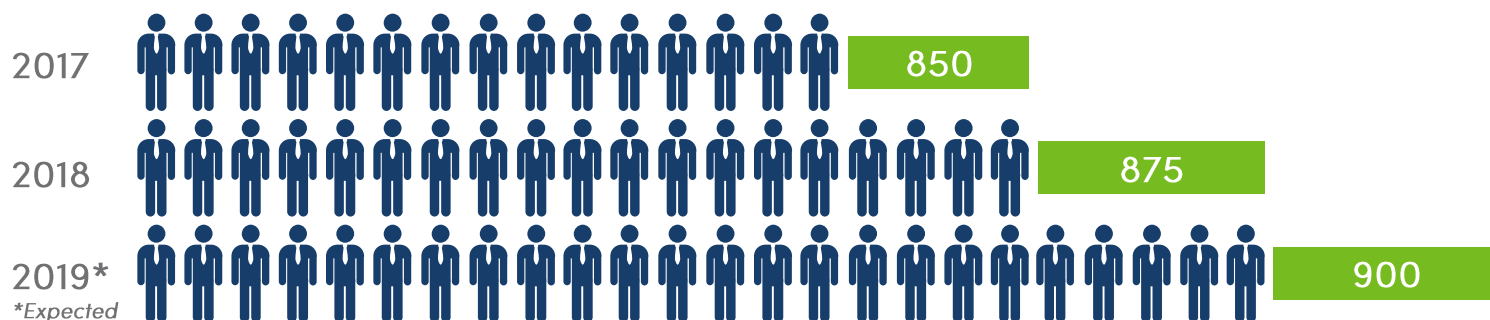

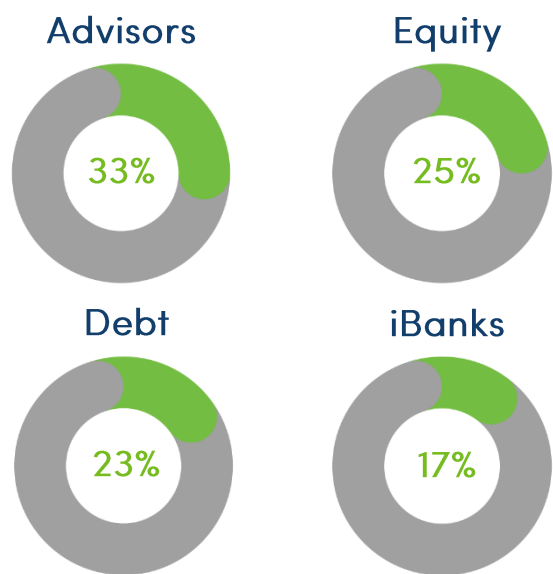

Wine Tasting Gala Metrics

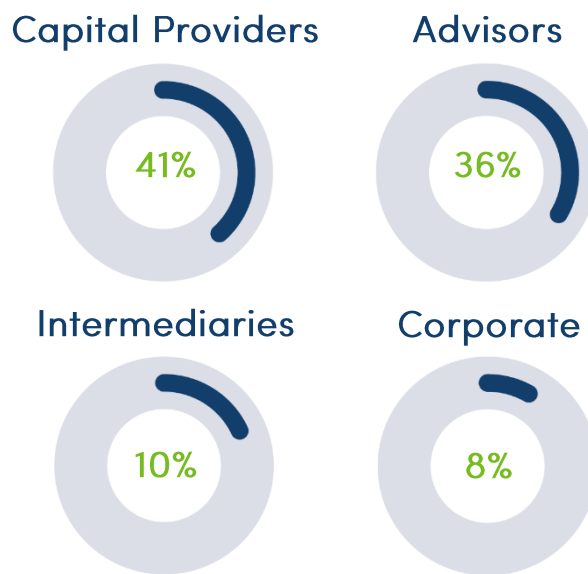
Past Attendance
