### Overview

The afternoon will focus on 30 minute, substantive 1:1 meetings with bankers. We have capped the DealSource attendance at 20 sponsors and 30 bankers with a commitment of 6 meetings (sponsors send their top 12 choices of bankers and ACG tries to guarantee you will get at least 8 of those meetings).

For the beer tasting, we pair a PE firm with a banker that you didn't meet with for additional networking and you are given beer to pour. We have prioritized quality and relevance.


