Capital Providers

A member who works for an equity group and whose job description includes purchasing ownership interests in companies (public or private) for the purpose of growing the companies through internal growth, add-on acquisitions, consolidations, joint ventures, alliances, licensing, franchising, etc. with the ultimate goal to exit from the investment through a partial or complete sale of the company to a third party, a recapitalization, or an IPO.

EGF	Equity Group Managing Fund- Member is an officer, VP or above, employed by an equity group which is managing a committed equity fund	Officer/Vice President level or above at a firm that has completed a deal with over \$10 million in revenue over last three years
EGU	Equity Group Not Managing Fund- Member is an officer, VP or above, employed by an equity group which is not managing a committed equity fund	Officer/Vice President level or above at a firm that has completed a deal with over \$10 million in revenue over last three years
LS	Senior Debt/Mezzanine Lender	Vice President level, or above at an institution focused on M&A activities

Intermediaries

Member is an intermediary whose services include bringing buyers and sellers together and/or identifying sources of debt and equity financing.

Advisors

A member who generates income from providing services to corporate and/or equity group member.

AT	Advisor-Attorney Member is an attorney whose services include advising corporate and/or equity group members	Partner level with focus on M&A activities, serving clients with annual revenue over \$10 million
ACO	Advisor-Consultant/Other Member is a consultant whose services include providing strategic planning advice to corporate and/or service member and equity financing	Officer/Vice President level or above with focus on M&A activities, serving clients with annual revenue over \$10 million
